Statement on: Safe Drinking Water and Toxic Enforcement Act of 1986 (California Proposition 65)

Dear Sir or Madam,

thank you for your request, regarding the Safe Drinking Water and Toxic Enforcement Act of 1986 (California Proposition 65).

We are pleased to declare as it follows:

 As far as we can, we observe current developments in the field of "Safe Drinking Water and Toxic Enforcement Act of 1986 (California Proposition 65)" as well as related aspects in order to be able to respond to any requirements. Please note that our company does not fall within the scope of the California Proposition 65. The key-message of this regulation, is the following:

"No person in the course of doing business shall knowingly and intentionally expose any individual to a chemical known to the state [California; editor's note] to cause cancer or reproductive toxicity without first giving clear and reasonable warning to such individual [...]" (HSC § 25249.6)¹.

It is a specific legal regulation of the US state of California. The "California Proposition 65" therefore focuses on affected economic operators in the US state of California.

In addition, it is our fundamental concern to pay close attention to developments in ethics, social and environmental standard.

 For the supply of the raw materials qualified and trustworthy sources or distributors are very important for us. We currently know our suppliers for years and they are familiar with our quality requirements. We are also in close contact with our suppliers.
